**Interference Complaint**

Dear Ms. Dortch:

Elohim Group Corporation (“Elohim”), by its attorney, hereby responds to the Commission’s Letter dated August 24, 2017 issued by James D. Bradshaw, Deputy Chief, Audio Division, Media Bureau (“Letter”). In an Interference Complaint filed on June 28, 2017 by Bible Broadcasting Network, Inc. (“BBN”), it was alleged that Station W228DF was causing interference to FM Translator W228BK. The Letter required Elohim to investigate each claim of interference, and to provide a detailed Report concerning steps taken to eliminate any such interference. This letter, and the accompanying materials, provides that Report.

A total of four complaints were filed as a part of the Interference Complaint submitted by BBN. Those were filed by Fanchao Yi, Barbara Snyder, Rita Evans, and Vivian A. Watson. Each complaint is addressed individually below:

Fanchao Yi. See Attachment 1. No telephone number was provided in the Interference Complaint for Fanchao Yi. A letter there was sent to Mr. Yi. Mr. Yi responded by email and indicated that he wished only to communicate with W228DF by email. A response was sent, explaining that W228DF wished to work with him to resolve any interference that may exist. Although Mr. Yi indicated interference is occurring, four attempts have been made to obtain more information concerning the nature of the interference and on what equipment the interference is occurring. Mr. Yi has stopped responding to inquiries sent by W228DF’s representatives.

Therefore, W228DF has responded to this complaint to the full extent that it is capable. Under Section 74.1203(b) of the Commission’s Rules:

If a complainant refuses to permit the FM translator or booster licensee to apply remedial techniques which demonstrably will eliminate the interference without

impairment to the original reception, the licensee of the FM translator or booster station is absolved of further responsibility for that complaint.

47 C.F.R. § 73.1203(b). See also, *Creation of a Low Power Television Service*, 31 FCC Rcd 3315, 3329 ¶ 31 (2012) (“as is the case with other types of interference complaints, the staff has considered only those complaints where the complainant cooperates in efforts to identify the source of interference and accepts reasonable corrective measures”) (footnote omitted). By not responding, the complainant is not cooperating in the attempts of W228DF to affirmatively identify and eliminate any interference that may be occurring. Therefore, W228DF should be absolved at this time for further responsibility for that complaint.

Barbara Snyder. See Attachment 2. Barbara Snyder was contacted by means of a visit to Ms. Snyder’s home. After further inquiry, Ms. Snyder decided she did not wish to pursue her complaint, and signed a document to that effect.

Elohim is treating this Complaint as resolved.

Rita Evans. See Attachment 3. This complaint was investigated by a visit to Ms. Evans’ home. At the time of a second visit to her home, the investigator was informed by Ms. Evans’ husband that the representatives of W228DF were not to “bother[] his wife” about the Listener Declaration that she had provided, and even after being told that they were there to attempt to resolve the problems she was experiencing, he indicated “they did not want to talk” about the matter further.

W228DF therefore has responded to this complain to the full extent it is capable, and the complainant’s representative has clearly indicated that no further efforts to resolve the complaint will be appreciated or permitted. Under Section 74.1203(b) of the Commission’s Rules:

If a complainant refuses to permit the FM translator or booster licensee to apply remedial techniques which demonstrably will eliminate the interference without impairment to the original reception, the licensee of the FM translator or booster station is absolved of further responsibility for that complaint.

47 C.F.R. § 73.1203(b). See also, *Creation of a Low Power Television Service*, 31 FCC Rcd 3315, 3329 ¶ 31 (2012) (“as is the case with other types of interference complaints, the staff has considered only those complaints where the complainant cooperates in efforts to identify the source of interference and accepts reasonable corrective measures”) (footnote omitted). By not allowing further access to Ms. Evans, the complainant is not cooperating in the attempts of W228DF to affirmatively identify and eliminate any interference that may be occurring. Therefore, W228DF should be absolved at this time for further responsibility for that complaint.

Vivian A. Watson. See Attachment 4. W228DF investigators were able to interview Ms. Watson. Even though W228DF has only been on the air since March 2017, Ms. Watson indicated she has been experiencing the interference that she currently is receiving has been occurring for the past 1-2 years, *i.e.*, long before W228DF began operations. Notably, there also was no interference at the time of the interview. Ms. Watson indicated that she receives interference “mostly at night and mornings and 9-11 am on Saturdays” during children’s programming. The investigator for W228DF offered to return in the event she had the problem again.

It is clear that whatever interference Ms. Watson is receiving is not from W228DF. Nevertheless, W228DF remains ready to address any problems in the event facts or circumstances change. Elohim is treating this Complaint as resolved.



For your information, here are the details of the interference, if you need more information, please contact through email:

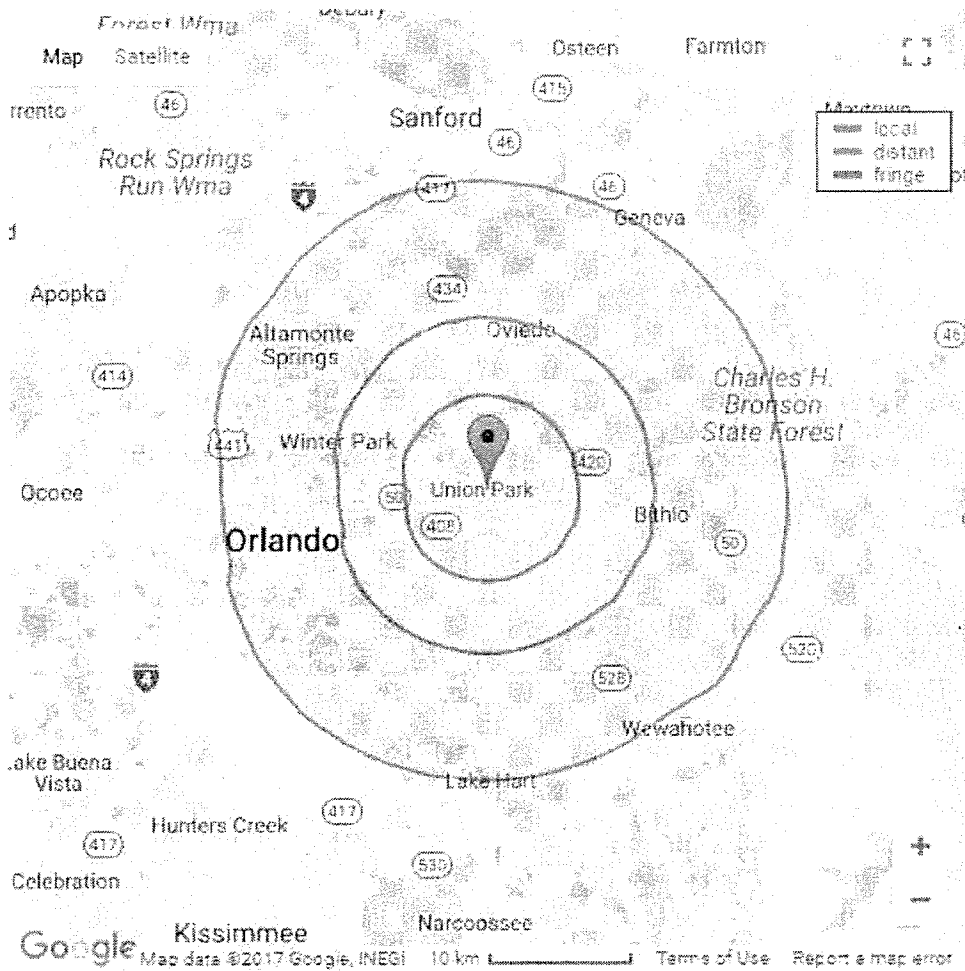
I have listened 93.5 (BBN) FM on my way to work or back from work for years without problem (from zip 32817 to zip 32803 or vice versa) . Their messages inspired me a lot. It is like a spiritual food for me. And I got the interference of OK Orlando 93.5 which began this year. Because of the interference, I cannot listen to BBN for months.

Here is the coverage map of 93.5 FM (union park), and here is the explanation of the circles (from <https://radio-locator.com/cgi-bin/page?p=maps>)

"The red, purple, and blue lines correspond to the "local", "distant", and "fringe" predicted coverage areas of each radio station:

- **Local Coverage:** Within this area, you should be able to receive the radio station on almost any radio with moderately good to very good reception.
- **Distant Coverage:** Within this area, the signal of the radio station may be weak unless you have a good car radio or a good stereo with a good antenna. You may not be able to receive the station at all on walkmans or other portable radios.
- **Fringe Coverage:** Within this area, the station's signal will be very weak. You may be able to receive this station if you have a very good radio with a good antenna, but it's possible that interference from other stations may prevent you from picking up these stations at all."

## Predicted Coverage Area for W228BK 93.5 FM, Union Park, FL



The interference I experienced was even in the local coverage area (red circle), where I live. Sometimes it is like the mix of two stations voice, or totally occupied by "OK Orlando 93.5". And beyond local coverage area, the interference is even worse. My workplace is in the blue fringe area (west side of the circle). I used to listen 93.5 FM (union park) without problem in these areas, but now I almost cannot find the station, it was occupied by "OK Orlando 93.5".
