Dear Mr. Price:

This is in reference to the request filed on December 4, 2017. TMTL requests a further extension of the STA granted on December 4, 2012, to continue operation with night DA parameters at variance to allow time to file the required FCC Form 302 application.¹ In support of the request, we noted that the application was not filed during the past six month period to update all operating parameters.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of STA IS HEREBY GRANTED, and TMTL may continue to operate with night DA parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits, with no change to the licensed daytime 1 kW ND operation. TMTL must further reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

¹ KOSY(AM) is licensed for operation on 790 kHz with 1 kW (ND) day and 0.5 kW (DA) night.

TMTL must file an FCC Form 301 application first to modify the antenna system if any other type of parameter changes are needed to the antenna system (such as coordinate correction greater than three seconds, or ground system changes).

This authority expires on **June 28, 2018**.
