#### **INTERFERENCE COMPLAINT**

Mountain Educational Services Corporation ("MESC"), licensee of low power FM station WSDA-LP, Trenton, Georgia (Facility ID #124572), by counsel and pursuant to §74.1203 of the Commission's rules, hereby submits this complaint of actual interference to the reception of WSDA-LP caused by signals transmitted by co-channel FM translator station W254DB, Chattanooga, Tennessee (Facility ID #156865), licensed to Jackson Telecasters, Inc. ("JTI").

Section 74.1203 of the Commission's rules states that

Media Bureau

An authorized FM translator . . will not be permitted to continue to operate if it causes any actual interference to: . . . The direct reception by the public of the off-the-air signals of any authorized broadcast station. . . . Interference will be considered to occur whenever reception of a regularly used signal is impaired by the signals radiated by the FM translator . . . regardless of the quality of such reception, the strength of the signal so used, or the channel on which the protected signal is transmitted.

Submitted herewith are statements from 12 members of the public who aver that their ability to use the WSDA-LP signal is hampered by interference from W265AV. There is clear and abundant evidence of actual interference.
