Dear HFB staff:

This is in reference to the request filed on February 23, 2018. HFB requests a further extension of the STA granted on January 29, 2016, to operate with a drop wire antenna at the KLSD(AM) site to allow time to file the required FCC Form 301 application (due to loss of the licensed site).¹ In support of the request, HFB states that additional time is needed to file the application.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA is GRANTED, and HFB may continue to operate with the following facilities:

Geographic coordinates	32° 43' 51" N, 117° 04' 59" W (NAD 1927)
Frequency	1130 KHz
Hours of operation	Unlimited


¹ KSDO(AM) is licensed for DA operation on 1130 kHz with 10 kW (day and night) using different patterns.

Operating power	2.5 kW
Antenna type	Drop wire antenna (hung from Phillystran tower guy rope)
Antenna radiator height	64° (47.2 ms)
Antenna efficiency	239.5 mV/m/kW at 1 km

It will be necessary to further reduce power or cease operation if complaints of interference are received. HFB must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. HFB must file the application before or immediately after final action has been taken on the proposed rules mentioned in MB Docket 13-249.²

This authority expires on **September 12, 2018**.
