Declaration of John Higgs

I, John Higgs, do hereby declare and state under penalty of perjury:

I am Member of Broadcast South, LLC, licensee of, *inter alia*, AM Station WBHB, Fitzgerald, GA (Facility ID No. 39476) (the "Station"). With this Declaration I am also tendering the Station's license for cancellation.

I have reviewed the letter of the FCC Audio Division, dated February 28, 2018, inquiring about the operating status of the Station since January 1, 2017 (the "Status Inquiry Letter").

The Station is located on Roanoke Drive in Fitzgerald, GA in the same facilities as FM Stations WZKK, Tifton, GA (Facility ID No. 50535) and WRDO, Fitzgerald, GA (Facility ID No. 24738). For years the Station has caused very significant distortion to the signals of both WZKK and WRDO, and even to fax machines, telephones, and other appliances in the same building.

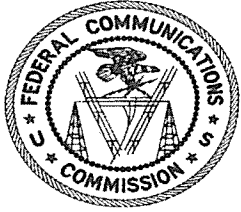
I have employed many different engineers to study and resolve the distortion issues caused by the Station, but none has had any success. These engineers include, but are not limited to, Larry Nixon, Bud Mitchell, Victor Vickers, Charlie Sweat, our present engineer, Ryan Hanna, and tower expert Grant Balwantz.

None of these engineers could resolve the distortion issues caused by the Station. I instructed our Chief Engineer to turn on the Station's transmitter approximately once per week to broadcast the Station and continue searching for a remedy. However, the distortion caused by the Station has never subsided. I offered Wiregrass Technical College the Station for free, but it had no interest in accepting the Station's license.

I was in the process of cancelling the Station license when I received the Status Inquiry Letter. With no other viable option, I am tendering the Station's license for cancellation with this Declaration.
