Birach Broadcasting is again asking for an extension of their STA for AM station WBVA 1450 Khz in Bayside, VA. This has been an ongoing issue for several years with this station and others owned by Birach Broadcasting. It is my belief that Birach Broadcasting no longer has the intention of actually putting the radio station back on the air, but is merely stringing the FCC along until a buyer is found for this station.

Birach Broadcasting owns many, many other stations and some have this same problem.

Could you look into this STA application and research the many applications over the past decade ? I believe there are others who could make much better use of this license and frequency. I believe a new owner could serve the public interest in a much better fashion.
