Please find attached hereto a further supplement to the October 10, 2017 response of ABC Radio Los Angeles Assets, LLC ("ABC Radio") to the request for 30-day letter of AMFM Broadcasting Licenses, LLC, as filed today in CDBS. This supplement reports that ABC Radio has resolved the interference concerns to the satisfaction of KGGI's chief engineer, Richard Mena. Note that ABC Radio also has submitted an amendment to its pending CP application specifying technical parameters that match the K256CX operation that has been confirmed by Mr. Mena as having resolved KGGI's interference concerns.
