Special operating conditions or restrictions:

- The application BML-20180216AAZ to convert KCEO (AM) from noncommercial 1 educational status to commercial status IS GRANTED, effective as of the grant date of this license.
- The permittee/licensee must reduce power or cease operation as 2 necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- 3 Licensee shall be responsible for satisfying all reasonable complaints of blanketing interference within the 1 V/m contour as required by Section 73.88 of the Commission's rules.
- Day and Night arrays consist of towers South, Center, North and West 4 referenced in that order.
- Ground system consists of 120 equally spaced, buried, copper radials 5 about the base of each tower, each 75 meters in length except where terminated by property boundaries or where intersecting radials are shortened and bonded to a transverse copper strap midway between adjacent towers.
- The licensee shall perform the measurements described in Section 73.155 6 at least once within each 24 month period.
