The failure of the facility to so operate will result in the rescission of this grant, dismissal of the license application and the forfeiture of the associated construction permit pursuant to 47 C.F.R. § 73.3598(e) unless the licensee rebuts the presumption that the authorized facilities were temporarily constructed.
- 2 Ground system consists of 120 equally spaced, buried, copper radials about the base of the tower, between 57.6 meters and 100.6 meters in length plus 120 interspersed radials between 18.3 meters and 30.5 meters in length
- 3 Licensee shall be responsible for satisfying all reasonable complaints of blanketing interference within the 1 V/m contour as required by Section 73.88 of the Commission's rules.
