On behalf of The Florida Gulf Coast University Board of Trustees, we respectfully request that the FCC update CDBS and the Media Bureau's records to reflect a correction to the licensee name listings for noncommercial educational radio stations WGPU-FM, Fort Myers, Florida and WMKO(FM) Marco Island, Florida, and noncommercial educational television station WGPU(TV), Fort Myers, Florida.

For WGPU-FM, WMKO(FM), and WGPU(TV), the licensee requests that the FCC correct the licensee name from "Board of Trustees, Florida Gulf Coast University" to "The Florida Gulf Coast University Board of Trustees".
