Dear Sir:

We understand that you recently acquired the license for W275BD, Greenfield, Indiana (Translator), from Indiana Community Radio Corp.<sup>1</sup> Enclosed please find copies of a Memorandum Opinion and Order<sup>2</sup> and a letter that address complaints that the Translator is interfering with listener reception of a WXCH(FM), Columbus, Indiana. These complaints were filed prior to your acquisition of W275BD.<sup>3</sup>

As the Translator's current licensee, New Beginnings Movement, Inc. (New Beginnings) is responsible for adhering to both decisions and taking the steps discussed in the Letter. The Letter requires these steps to be taken within 30 days. However, because the Letter was not sent to New Beginnings initially, we will permit New Beginnings to take these steps within 30 days of the date of this letter. Please note that, pursuant to the Letter, if New Beginnings "fails to fully resolve and satisfactorily document its resolution of the interference experienced by these complainants," we will "take whatever actions are necessary to eliminate the interference."<sup>4</sup>

<sup>4</sup> We note that, in response to our recent grant of a construction permit to modify the Translator's facilities, File No. BPFT-20180417AAE, *Broadcast Actions*, Public Notice, Report No. 49228 (MB May 3, 2018), the licensee of WXCH(FM) submitted a pleading requesting that we "order W275BD to cease operations immediately until such time as W275BD commences operations with the newly permitted facilities." Reising Radio Partners Inc. Comments (May 1, 2018). New Beginnings opposed the pleading and the licensee replied. New Beginnings Movement, Inc. Opposition to Comments (May 14, 2018); Reising Radio Partners Inc. Reply to Opposition to Comments (May 24, 2018). We will not require the Translator to cease operations until it can commence operations with its newly permitted facilities. The Letter requires New Beginnings to expeditiously and fully remediate all interference experienced by the affected station's listeners. Letter at 7. Should New Beginnings fail to do so, at that time, we will take whatever actions are necessary to eliminate the interference. *Id.*
