Gene: This STA request IS DISMISSED 6/18/2018.

My August 3, 2017 e-mail predated the October 13, 2017 letter you reference below, and so the reference to 10 watt operation was correct at the time my reply was issued. The subsequent October 13 letter suspended all operations from the specified facility, specifically including the 10 watt operation previously allowed. I do not see any basis for circumventing the letter decision via STA.

Mr. Hopper:

Your STA request for operation at 0.010 kW (10 watts ERP) IS DENIED.

This is because your STA request shows an increase in W265AV's antenna height of 57 meters, above the licensed antenna heights. Such a change requires the filing and grant of a construction permit application on FCC Form 349, before construction can take place, or operations commence with the changed facilities. You may submit a construction permit application at any time.

W265AV may continue to operate with 0.010 kW in accordance with the reissued license BLFT-201740915AAD (see the staff's July 9, 2017 letter to W265AV).
