Notification of License Expiration

Dear Licensee:

Our records indicate that the station referenced above has been silent since at least May 19, 2016. Therefore, pursuant to Section 312(g) of the Communications Act, as amended,¹ the station's license expired as a matter of law at 12:01 a.m., May 20, 2017. Unless we receive documented evidence² within 30 days of the date of this letter that our records incorrectly reflect the operational status of the station and that, in fact, the station returned to the air with authorized facilities at some time between May 19, 2016, and 12:01 a.m., May 20, 2017, the Commission's public and internal databases WILL BE MODIFIED to indicate that the broadcast license for the referenced station is EXPIRED, that the station's license is CANCELED as a matter of law, and that the station's call sign is DELETED.

Finally, we note that it is imperative to the safety of air navigation that any prescribed painting and illumination of the station's tower be maintained until the tower is dismantled. Accordingly, the owner of the tower where the referenced station's transmitting antenna is located is required, pursuant to 47 U.S.C. Section 303(q), to maintain the tower in the manner prescribed by our rules and the terms of the cancelled license.³

**RESPONSE OF REYNOLDS TECHNICAL ASSOCIATES, LLC
TO FCC LETTER REGARDING STATUS OF
W257AA CLANTON, AL (1800B3-KC)**

FACILITY ID No. 149788

The instant narrative is submitted in response to a certified letter dated April 19, 2018 (1800B3 (KC)) from the Audio Division, Media Bureau. The letter informs Reynolds Technical Associates, LLC ("RTA") that its records indicated FM translator W257AA had been silent since May 2016. As a result the station's authority to operate expired May 20, 2017. See Exhibit A. The letter called for documentation that the station had returned to the air prior to May 20, 2017.¹ This reply is in response to that request.

HISTORY

W257AA was purchased by RTA as part of the AM Revitalization effort and moved from La Grange, GA to Clanton, AL in the filing window allowing for 250 mile relocations (BALFT—20160526ABW). In this window FM translators could be identified with AM class C or D stations. WKLF (AM) Clanton, AL is a class D, therefore it qualified for an FM translator. The sale was consummated on February 1, 2017 and W257AA began operation immediately under RTA ownership pursuant to its permit granted November 7, 2016. See BPFT-20161024ADI.² RTA did not realize that it failed to file the Form 350 until receiving the FCC certified letter on April 30, 2018. RTA has separately filed a license application to correct that oversight.³ Nevertheless, RTA will provide documentation that Station W257AA resumed operation at its authorized transmitter site on February 1, 2017 once closing on the transaction occurred.

VERIFICATION OF OPERATION

RTA submits the following letters, billing statements, programming logs and engineering maintenance logs to verify that W257AA was on the air prior to May 20, 2017.

I. Comments of Chilton County Advertising Clients and Residents

The best measure of a radio station's time on the air or broadcast times is information garnered from its advertising clients. Clients listen for their commercials. With this premise in mind RTA, through its sales representatives, contacted several of the WKLF (AM) and W257AA advertisers for statements of verification. The advertisers were told to examine their records for verification that they advertised and listened to WKLF/W257AA during a specific time period. The calendar dates chosen were between the RTA start of operations with W257AA (February 1, 2017) and the anniversary date of the station going silent (May 20, 2017). The clients who complied did so gladly. The majority of the letters attached are longtime advertising clients of WKLF (AM) who are extremely pleased to have their ads also aired on the FM translator especially since it allows for nighttime broadcast of events that were previously unavailable to them. This is especially true concerning school activities, church functions and city and county government's public interest matters.

II. Client Billing Statements

The billing statements are copies of the exact one which were mail to WKLF/W257AA advertisers. The invoices correspond to the same time period mentioned in the client letters, February 1, 2017 to May 20th 2017.

III. Engineering Maintenance logs

The maintenance logs of engineer Robert Williams chronicle the technical side of the process. His pictures of the transmitters, tower and antenna are also included.

IV. Other Verifying Data

W257AA operates on the same tower structure as WKLF(AM) which is owned by an RTA affiliated entity. Therefore, many suggested items for inclusion the Commission's letter of April 19, 2018 proposes are not applicable. See FCC letter footnote 2.

For example;

- 1) Leases – there are no W257AA leases since its antenna is located on the co-owned WKLF (AM) tower and its studio is the same as that used by WKLF. Both tower and studio is owned by co-owned Great South Wireless, LLC.
- 2) Personnel records – the employees responsible for Station WKLF are also responsible for Station W257AA.
- 3) Engineering records – the W257AA maintenance logs are included.
- 4) Station (program) logs – several programming logs for WKLF in the specific time period are included.
- 5) Quarterly issues – are in the WKLF public file posted on line.
- 6) Invoices – invoices to advertising clients are included. No separate invoices (accounts payable) are received for W257AA.
- 7) Checks written or received – none are designated specifically for W257AA.
- 8) Charges for equipment and its installation – all RF apparatus for W257AA was taken from the RTA inventory of RF equipment gathered from of engineering services to various clients. None was

purchased specifically for the instant installation. All labor was from either RTA principals or employees.

- 9) Coordinates of transmitter/antenna location – The operating site of W257AA is with an antenna located on the WKLF tower. Therefore its coordinates are the same as those of WKLF(AM); 32° 49' 55" N; 86° 41' 36".

Conclusion

Even though the instant document focuses on the time period from February 1, 2017 (date of sale consummation and RTA beginning operations as owner) until May 20, 2017 (anniversary of W257AA going silent in La Grange), this narrative should in no way be construed as stating that W257AA did not continue to operations after May 20, 2017. RTA began operation of W257AA as the owner/operator on February 1, 2017 and began programming late that same day. Other than short durations of power outages, storm damages and equipment malfunctions, W257AA has provided continuous service to Clanton and Chilton County from February 1, 2017 until the present time.

RTA recognizes that it failed to file Form 350 once its notice of consummation was filed and operations began. Therefore, it is RTA's request that the Commission accept this reply to its letter of April 19, 2018 as documentation of W257AA being on the air from February 1, 2017 until the present time.

Measurements were made at a distance of approximately 1 KM from the antenna. The location was at the old service station at the intersection of Alabama hi-way 22 and Chilton county road 37.

Frequency was checked with a Motorola R2038HD Communication Service monitor.

The R2038 was allowed to warm up for 30 minutes and its time base was checked against WWV on 10Mhz and showed an error of less than 1Hz.

The frequency of W257AA was checked with no modulation and showed to be -157Hz or 95.499843Mhz. This is well within the 2000Hz limits set by the FCC.

Harmonics and spurious emissions were checked with a Hewlett- Packard 8557A spectrum analyzer and the Motorola R2038HD.

. No spurious emissions were noted from 45Mhz to 875Mhz. Special attention was paid to the 2nd thru 9th harmonics. Nothing was readable at a distance of 1Km.

Readings made at the transmitter site showed emissions from 120Khz to 240Khz were -27 db down from the carrier and emissions from 240Khz to 600Khz were reading better than 40 db down. This reading is meeting the requirements of -25db for 120 to 240Khz and -35db for 240 to 600Khz

Modulation was checked and found not to be exceeding the 100% limit of 75Khz. Stereo pilot was checked at 8.9% or 6.7Khz deviation.
