Dear Mr. Torrado:

This is in reference to the request filed on August 13, 2018. JVC requests an extension of the STA granted on January 30, 2018, to continue operating during nighttime hours with parameters at variance to allow time to resolve all equipment problems.¹ In support of the request, JVC stated that it estimates all repairs should be completed within the next 60 days.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

We noted that the previous STA expired on July 29, 2018, therefore the authority granted will not cover the period between the expiration of the prior STA and the filing of the instant request, and is without prejudice as to whatever action the Commission may take with respect to

operation of station during that time period.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and JVC may continue to operate ND using the daytime tower with a maximum of 5 kW day and 0.25 kW at night. JVC must reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. JVC must submit an e-mail to my attention to certify the date the station resumed licensed operations per the last license (BZ-19940715AB) with negligible changes.

This authority expires on February 24, 2019.
