Dear Federal Communications Commission:

KQRU-LP Santa Clarita wishes to submit a request for Silent Special Temporary Authority (Silent STA).

Reason for going Silent: Technical Date commence silence: 08/14/2018

Station requires going silent due to unforeseen circumstances concerning the availability of electrical power at the licensed site. Licensee needs to dig a trench (or find another site) to run power to the current site. During the *duration TBA* the station will need to be off the air. The history concerning this item includes the following:

- (1) SCOPE obtained assurances through AT&T tower for the current licensed site going back to 2013 (email below from Mr. Durbin).
- (2) SCOPE was granted CP BNPL-20131115AAD 08/20/2014 and worked with AT&T to secure the site specifics.
- (3) Everything was appropriate until summer 2017 when SCOPE was informed Crown Castle (CC) had purchased the tower site KQRU-LP was to co-locate at from AT&T. CC Representative Laura Whitten had explained that CC now manages the site, but CC did not have the power right of way to the site anymore (email from Whitten below). KQRU-LP was placed on the area and has operated off generator power.
- (4) Running off a generator is not long-term sustainable. KQRU-LP cannot file a minor change (form 318) to move anywhere to the east due to K300CZ short-spacing (on 08/18/2015 BMPFT-20150716AAA was granted for K300CZ, short spacing the KQRU-LP permit). It cannot move anywhere W/SW due to minimum spacing with KSXS-LP. And to the North there is minimum spacing with a Bakersfield full power facility. It cannot even move off the hill into the adjacent housing tract because the zero-population second adjacent overlap is 140.3 m. It has been literally locked to this site for three years.
- (5) KQRU-LP needs to go silent to invest in power upgrade to run power to the transmitter shack. A power trench needs to be run to connect CC's facility to the grid.
