Dear Mr. Ryson:

This is in reference to the request filed on October 9, 2018. CBS requests an extension of the STA granted on March 11, 2016, to continue operating with parameters at variance to allow time to file the required FCC Form 302 application.<sup>1</sup> In support of the request, CBS states that due to on-going construction at the site, additional time will be needed to file the application to update all operating parameters.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

We noted that the previous STA expired on April 19, 2018, therefore the authority granted herein does not cover the period between that date and the filing of this request, and is without prejudice as to whatever action the Commission may take with respect to operation of station during



that time period.

Accordingly, the request for extension of STA IS HEREBY GRANTED, and CBS may continue to operate with parameters at variance and/or reduced power while maintaining monitor points within licensed limits. CBS must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **April 10, 2019**.
