Hossein –

On behalf of Summit Public Radio & TV, Inc., we hereby request extension of the STAs to operate the television translators with temporary call signs of K12EK and K08EM for an additional six months beyond the current STA expiration date of September 21, 2018. The reason is the same as in previous filings. Summit awaits an opportunity to file for new CPs for these facilities that provide television service to a population that otherwise would not receive the signals of the stations carried because of mountainous terrain. I am forwarding copies of the most recent extension grants. Those grants were processed in CDBS and you

advised us when you moved the facilities back into CDBS that we could file email requests for additional STA extensions. Summit will pay the fees online with Form 159 when you tell us that the system is ready to accept the payments.

Please let me know if there is anything else we need to do to get the requested extensions.
