Dear Mr. Cooper:

This is in reference to the request filed on October 29, 2018. DNBC requests an extension of the STA granted on March 7, 2018, to continue operating using the daytime licensed facility to allow time to file the required FCC Form 302 application to cover BP-20180409AAD.¹ In support of the request, we note that DNBC will require additional time to complete all work and file the application.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

We noted that the previous technical STA expired on June 7, 2018, therefore the authority granted herein does not cover the period between that date and the filing of this request, and is without prejudice as to whatever action the Commission may take with respect to operation during that time.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and DNBC may continue to operate daytime-only with its licensed 5 kW antenna system. DNBC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

¹ WKCT(AM) is licensed for operation on 930 kHz with 5 kW ND day and 0.5 kW DA night, and BP-20180409AAD authorizes use of daytime tower at night using 0.059 kW.

This authority expires on **April 30, 2019.**
