Please be aware that unauthorized operations — operations with facilities not authorized by a current STA or license — do not count as a resumption of operations within one year for the purposes of Section 312(g) of the Communications Act, and cannot be used to avoid the consequences of Section 312(g). W265AV under this STA will rebroadcast WCCV(FM). When W265AV commences operation with full parameters authorized by the station's construction permit, W265AV must comply with the Rules if it continues to rebroadcast WCCV(FM).
