This is in reference to the above application and the request for an extension of the construction permit period received on February 5, 2019. For the reasons stated below, the request for an extension will be denied.

Section 73.3598 of the Commission's Rules¹ allows extension of an original LPFM construction permit for an additional 18 months. The instant permit is not an original permit therefore an extension per Section 73.3598 is not applicable. Tolling of the construction permit deadline can be requested under certain specific conditions that prevent construction due to causes not under control of the permittee. These causes include acts of God (such as floods, tornados, hurricanes, or earthquakes), administrative and judicial challenges to the permit's grant, or a pending request for international coordination. Tolling requests should be submitted 30 days before the permit's expiration.

Accordingly, in light of the above, the request for an extension of the construction permit period for BPL-20170718AGE IS HEREBY DENIED. These actions are taken pursuant to 47 C.F.R. § 0.283.
