**OPPOSITION TO INFORMAL OBJECTION AND
REQUEST FOR EXPEDITED ACTION**

Centro Cristiano de Vida Eterna ("CCVE"), proposed assignee of Station KJJB(AM), Eagle Lake Texas, hereby submits its Opposition to the "Informal Objection" ("Objection") filed by James B. Davis ("Davis") with respect to the above-referenced application. With respect thereto, the following is stated:

The Objection should be dismissed. The application is for assignment of license. As such, the sole inquiry in this proceeding is the qualifications of the proposed assignee to become licensee of Station KJJB(FM).

Although Mr. Davis has filed an Objection to a grant of the assignment application, Mr. Davis has not provided facts sufficient to show that grant of the assignment application would be *prima facie* inconsistent with the public interest, convenience, and necessity, as required by Section 309(d)(1) of the Communications Act of 1934, as amended. 47 U.S.C. § 309(d)(1). As the Commission has noted, notwithstanding the obvious distinctions between petitions to deny and informal objections (compare Sections 73.3584 and 73.3587 of the Commission's Rules), informal objections like petitions to deny must also contain adequate and specific factual allegations

sufficient to warrant the relief requested. See *Area Christian Television, Inc.*, 60 R.R.2d 862, 864 ¶ 6 (1986); *WFBM, Inc.*, 47 F.C.C.2d 1267 (1974), and *License Renewal Applications - Los Angeles, California, Area*, 68 F.C.C.2d 75 (1978). Mr. Davis' informal objection fails in this regard. All that Mr. Davis presents is a list of previous applications and hearsay concerning the past operation of the station, together with an indication with the station is not currently built and operating. As reported to the Commission already, the station currently is silent. BLSTA-20181012AAU. In fact, an application is pending for relocation of the station to a new site. File No. BMPH-20181204AAK. These facts do not constitute a basis for denial of the application for consent to assignment.

This application has now been pending for nearly five months. CCVE stands ready, willing, and able to consummate this transaction and expeditiously restore operations for the station.

WHEREFORE, it is respectfully request that the Informal Objection, filed by James B. Davis, be denied.
