Dear Mr. Kennedy:

This is in reference to the request filed on March 20, 2019. Entercom requests an extension of the STA granted on July 18, 2016, to continue operating with parameters at variance to allow time to file the required FCC Form 302 application.¹ In support of the request, we noted that Entercom requested additional time to complete all remaining repairs and file the application (to update all operating parameters).

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA is **HEREBY GRANTED**, and Entercom may continue to operate ND with a maximum of 5 kW (day) and 1.25 kW (night) using its

licensed daytime antenna (or the auxiliary antenna specified below), or at night with DA parameters at variance and reduced power to maintain monitor points within licensed limits:

Hours of operation	Unlimited
Operating power	5 kW max (day), 1.25 kW max (night)
Antenna type	Existing tower

Entercom must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR 1.1310.

This authority expires on **September 20, 2019**.
