**Informal Objection** 

## Dear Counsel:

We have before us: (1) the referenced application for a license to cover a construction permit<sup>1</sup> for FM Translator Station W280EM (W280EM or Station) to operate on Channel 280 at Chicago, Illinois, (License Application) filed on January 20, 2015, by Windy City Broadcasting, LLC (Windy City or Permittee); and (2) an "Informal Objection" (Objection) to the License Application filed on January 26, 2015, by Adams Radio of Northern Indiana, LLC (Adams), licensee of Station WXRD, Crown Point, Indiana, alleging interference from W280EM.<sup>2</sup> For the reasons set forth below, we dismiss the Objection and grant the License Application.

The Station is a Translator for primary station WTMX(FM) (Skokie, Illinois), owned by Chicago FCC License Sub, LLC. On December 18, 2014, Windy City filed the Permit application which the Media Bureau (Bureau) granted on December 23, 2014. On January 20, 2015, Windy City filed the License Application to cover the Permit.<sup>3</sup>

On January 26, 2015, Adams filed the Objection to the License Application, alleging that the Station was interfering with reception of WXRD by certain listeners. In support, Adams attached an "updated" list of WXRD listeners who purportedly experienced interference.<sup>4</sup> In January and February 2015 Adams filed supplements that included information concerning additional listeners who purportedly experienced interference.

On February 10, 2015, Windy City noted that it had filed, on February 9, 2015, a modification application<sup>5</sup> (Modification Application) for permission to operate the Station with a directional antenna that it anticipated would address the alleged interference issues. On February 12, 2015, Adams objected to the Modification Application. Thereafter, Windy City filed a series of Special Temporary Authority (STA) applications involving temporary engineering operations and requests to remain silent.<sup>6</sup> On May 3, 2018, the Bureau dismissed the contested Modification Application.<sup>7</sup>

On May 30, 2018, Windy City resumed operations on W280EM, with the facilities specified in the License Application.<sup>8</sup> To date, Adams has not made any further filings in this interference proceeding.

In light of the foregoing, we find the 2015 purported interference issues to have been resolved. We, therefore, will dismiss the Objection and grant the License Application. However, we remind Windy

City of its continuing obligation under Section 74.1203 to resolve any future complaints, should they arise.<sup>9</sup>

**Conclusion.** Accordingly, in light of the discussion above, IT IS ORDERED, that the Informal Objection filed by Adams Radio of Northern Indiana, LLC on January 26, 2015, and supplemented on January 27, 2015, January 28, 2015, and February 9, 2015, IS DISMISSED.

IT IS ORDERED that the application of Windy City Broadcasting, LLC for a license to cover FM Translator Station W280EM, Chicago, Illinois (File No. BLFT-20150120AIR) IS GRANTED.
