
This is in reference to the request filed April 8, 2008, on behalf of Multicultural Radio Broadcasting Licensee, LLC ("MRB"). MRB requests, *inter alia*, Special Temporary Authority ("STA") to permit continued operation of both Expanded Band AM Station WWRU and commonly owned, associated lower band AM Station WJDM, beyond the fifth anniversary of the initial licensing of Station WWRU.¹ In support of the request, MRB states that the public interest would be served by allowing continued operation of both stations.

In order to provide for continued service to the public, we will grant STA for continued operation of Station WJDM beyond the expiration of the five-year term.²

Accordingly, the request for STA IS HEREBY GRANTED. Station WJDM may continue to operate with its currently licensed facilities³, notwithstanding Special Operating Condition #3 of License BL-20030206ADU. We extend the Section 73.3555 Note 10 authority for joint ownership to permit continued operation of Stations WJDM and WWRU.

This authority expires on **October 24, 2008**.

¹ License BL-200030206ADU was granted on April 9, 2003; the five-year anniversary is April 9, 2008. See Special Operating Condition #3 on the license. The license expired on June 1, 2006; A modified license, File No. BL-20031001CGF, was granted on February 1, 2006, and carried the same condition as Special Operating Condition #4. Application BR-20060131BHP, for renewal of the license, is pending before the Commission.

² A similar STA is concurrently being granted to Station WWRU.

³ In separate pleadings also filed on April 8, 2008, MRB: 1) conditionally surrendered the license of Station WJDM; 2) requested waiver of the Commission's rules and removal of special operating condition; and 3) requested stay of the requirement to surrender the license pending Commission action on its waiver request.
