Dear Mr. Holland:

This is in reference to the request filed on April 3, 2019. FRC requests an extension of the STA granted on March 31, 2017, to continue operating from an alternate site to allow time for Communication Technologies, Inc. (CTI) to assist in filing the required FCC Form 301 application (due to loss of the licensed site).¹ In support of the request, we noted that FRC stated they plan to file the application to propose a new permanent facility soon.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA is hereby GRANTED, and FRC may continue to operate with the following facilities:
