## **PETITION TO DENY**

Comes now, Metro North Communications, Incorporated, (hereinafter 'Metro') as Licensee of WLAK-AM, New Holstein, Wisconsin (1530 Khz.), by its President, Mark Heller, with a 'Petition to Deny' the application for a renewal or extension of a lapsed Construction Permit for Standard Broadcast facility, WCKG-AM, Elmhurst, Illinois, owned by DUPAGE RADIO.

Whereas, DUPAGE RADIO had previously been granted a Construction Permit, which expired in early June 2019, without any effort to construct same, for exactly the same facilities they are proposing now, this modification application flies in the face of current Commission rules and also, in the realm of fairness to other licensees on the same frequency and those located on adjacent channels, as well, including WLAK-AM.

At the time of the original Construction Permit filing, (BP-20151110AMR) Metro challenged the engineering on its face, due to the installation of two Illinois State Police transmitting towers, located within the immediate vicinity of the existing tower site. No effort to detune these towers, which are in fact, taller than the WCKG radiators, was ever mentioned in either application. Metro predicted it would have a negative effect on the signal.

In fact, it appears, that DUPAGE RADIO is simply re-filing the exact, identical engineering data from 2015, and trying to simply preclude other radio stations, trying to improve their own facilities, including WLAK-AM which is owned by Metro, while having to protect an obviously failed (and now, 'expired') construction project. The Commission does not allow for Extension requests, which this filing clear is. Three years is ample time, to change out a few capacitors, coils and replace a transmitter. DUPAGE RADIO had their chance, and they blew it! This was a two tower array!

Metro believes, as has been the Rule, that you simply cannot send in an old application with another filing payment to the Federal Communications Commission, and drag out a total of six years, without even attempting the original project in the first three years which was previously granted.

Clearly, there has been no emergency or sound reason, that would have precluded DUPAGE RADIO from building the original construction permit, within the original three year window. Clearly, there has been no change of control in the Licensee, as the elder father apparently purchased this station for the benefit of his son, for \$290,000 and from every indication the same facility is listed for sale today on websites of members of the National Association of Media Brokers, for over One Million dollars.

FCC Rules clearly state, under Part 73.3533(b) of the rules...

(b) The filing of an application for modification of construction permit does <u>NOT</u> (emphasis added) extend the expiration date of the construction permit.

That is precisely what DUPAGE RADIO is attempting to do. Within 72 hours of the expiration of the original Construction Permit, DUPAGE RADIO has attempt to 'game' the system, for its sole advantage. This is not in the Public's Interest, to evade the original rules and directions in the issuance of the Original Construction Permit, now lapsed.

Simply put, DUPAGE RADIO should not be rewarded, for its incompetence, lack of urgency, lack of initiative and motivation, to improve its facility, during the first three years of its original (now 'expired')

#### Construction Permit.

## **CONCLUSION**

Now, therefore, Metro North Communications, Incorporated respectfully requests that the Application for Modification of Standard Broadcast Facility WCKG-AM, be DENIED, for reasons stated above.
