Special operating conditions or restrictions:

- 1 The ground system consists of 120 equally spaced, buried, copper radials 213.4 m in length, except where truncated by property boundaries, plus an additional 120 interspersed radials 15.2 m to 21.6 m in length, about the base of the tower.

- 2 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
