- 4. Sam and Barry Wagenvoord agree to be personally liable for any and all Liabilities of Radio Hawaii, Inc. up to the date and prior to the aforementioned transfer of shares;
- Lola Wagenvoord agrees to be personally liable for any and all liabilities of Radio
   Hawaii, Inc. incurred after the date of the aforementioned transfer of shares;
- 6. Except for those covenants of paragraph 4 above, Defendant parties Sam and Barry Wagenvoord, Wagenvoord Advertising Group, Inc. and Plaintiff party Lola Wagenvoord, individually and as shareholders and derivatively on behalf of Radio Hawaii, Inc. agree to release each other from any and all obligations or liabilities beyond those agreed to herein.
