

AM BROADCAST STATION LICENSE

Subject to the provisions of the Communications Act of 1934, as amended, subsequent Acts, Treaties, and Commission Rules made thereunder, and further subject to conditions set forth in this license,<sup>1</sup> the LICENSEE

is hereby authorized to use and operate the radio transmitting apparatus hereinafter described for the purpose of broadcasting for the term ending 3 a.m. Local Time June 1, 1991 in accordance with the following:

This license is subject to the right of use of control by the Government of the United States conferred by Section 606 of the Communications Act of 1934, as amended.
