The licensee is responsible for addressing any complaints of interference that may arise.

When operations pursuant to this STA commence, the licensee shall file a **Notice of Resumption of Operations** in the FCC's CDBS electronic filing system.

We remind the licensee that the station's license will expire as a matter of law upon twelve consecutive months of silence [ending **August 22, 2019**], notwithstanding the grant of the present STA. See Pub. Law No. 104-104, 110 Stat. 56, Section 403(1) (1996) and Order, *Silent Station Authorizations*, FCC 96-218 (released May 17, 1996). See also Public Notice, *Expedited Processing of Applications Filed by Silent Stations*, DA 96-818 (May 22, 1996). Please be aware that unauthorized operations – operations with facilities not authorized by a current STA or license – do not count as a resumption of operations within one year for the purposes of Section 312(g) of the Communications Act, and cannot be used to avoid the consequences of Section 312(g). See *A-O Broadcasting Corporation*, FCC 08-10, 23 FCC Rcd 603 (2008).

This STA authority expires February 15, 2020.
