ENGINEERING STATEMENT REGARDING COMPLAINTS OF INTERFERENCE TO WVXG BY TRANSLATOR W236CZ

This engineering statement has been prepared on behalf of Delmar Communications, Inc., licensee of FM broadcast station WVXG, licensed to Mount Gilead, Ohio. The statement is based on reports furnished to the undersigned of interference presumed to be received from co channel translator W236CZ, licensed to Columbus, Ohio.

Attached is <u>Figure 1</u> depicting the licensed WVXG 60 dBu contour based on 72 evenly spaced radials. Population has been determined using the 2010 U.S. Census data. FCC terrain data and U.S. Census data provided by RadioSoft/LS Telecom for its well-known broadcast engineering software package ComStudy. Popoulation within the 80 dBu contour is 128,313 persons.

Based on FCC rule section 74.1203, Table 1, a population within the 60 dBu contour of between 1 and 199,999 persons requires a minimum of 6 interference complaints. WVXG herein submits complaints from 8 individuals at a total of 14 locations in compliance with the rule section.

Each listener complaint location has been plotted on a Google Earth map, attached as <u>Figure 2</u>, for purposes of determining coordinates for the listener location. <u>Table 1</u> lists each each person filing an interference complaint, the location of the interference complaint, geographic coordinates for the location of the complaint, the WVXG F(50,50) contour value at the coordinates, the W236CZ F(50,10) contour value at the coordinates and the interfering signal level in dB relative to the desired WVXG signal level.

Each complaint location is inside the WVXG 45 dBu F(50,50) contour and the W236CZ interfering signal exceeds the -20 dB co-channel value necessary for the WVXG signal to be properly protected.

A map figure is included for each interference complaint shown on <u>Table 1</u> showing the study coordinates, the WVXG service contour and the W236CZ interfering contour.




Contours at Chris Johnston location #2




Contours at Robert Schott Location




