#### SUPPLEMENT TO RENEWED INTERFERENCE COMPLAINT

1. Stewards of Sound, Inc. ("Stewards") hereby supplements its Renewed Interference Complaint against WRPX, Inc. ("WRPX"), based on interference caused by WRPX's FM Translator Station W279DD, Hudson, WI, to reception by regular listeners of primary station WWIB, Facility ID 63428, Hallie, WI. Stewards is the licensee of WWIB.<sup>1</sup> This Supplement responds to the Media Bureau's letter of August 22, 2019,<sup>2</sup> requesting that Stewards update its Renewed Interference Complaint filed October 31, 2018, and Supplement filed on April 22, 2019, to take into account the new rules adopted in *Amendment of Part 74 of the Commission's Rules Regarding FM Translator Interference*, 34 FCC Rcd 3457 (2019) ("*Translator Interference Order*").<sup>3</sup>

Stewards first filed an interference complaint with respect to W279DD on August
 24, 2017. After a cycle of pleadings, the Media Bureau directed the translator to cease operation.

*Letter to James A. Koerner, Esq.*, ref. 1800B3-KV, dated June 11, 2018. WRPX subsequently constructed modified facilities, including a directional antenna, with the main lobe oriented away from WWIB.<sup>4</sup> Because listeners continued to complain about interference, Stewards filed its Renewed Interference Complaint and Supplement.

3. This proceeding has been in progress for a long time. The listener complaints previously submitted by Stewards are now over one year old. The *Translator Interference Order* requires complaints to be less than one year old. Therefore, Stewards had to obtain new listener complaints to meet the Commission's new requirements, and it did so.

4. Attached as Exhibit 1 are 47 complaints written and signed by regular listeners to WWIB. Also attached as Exhibit 2 is an Engineering Statement that includes a map showing the locations of those listeners in relation to the WWIB predicted 45 dBu signal contour, which while not requested by the Media Bureau's letter, presents a clearer depiction of the contour and listener locations than previously submitted.

5. The Media Bureau's letter requested 10 things, each discussed in turn:

- a. The WWIB protected contour and population located therein. The population in WWIB's market is not large; but this pleading is supported by 47 listener complaints, which exceeds the 25-complaint minimum for a market of any size.
- b. Minimum number of complaints: The attached 47 listener complaints meets the minimum for any size market.
- c. Complaints signed and dated by listeners within one year: All 47 qualify.

- d. Listeners' full name, address, and telephone number: Included on each of the
   47 complaints.
- e. Description of listening locations where interference has been experienced: Included on each of the 47 complaints.
- f. Statement that listening occurs at least twice a month: Included on each of the
  47 complaints.
- g. Statement of no affiliation or relationship with station: Included on each of the
  47 complaints.
- h. Statement that the station is operating within its licensed parameters. The Declaration of Patrick Wahl, Chief Engineer for WWIB, attached as Exhibit 3, so states.
- i. Statement that the complaining station has used commercially reasonable efforts to inform the relevant translator licensee of the claimed interference and attempted private resolution. *See* Paragraph 5, *infra*.
- j. Undesired/desired ratio at each listener location: Included in the attached Engineering Statement for 44 of the 47 complaints.<sup>5</sup>

5. With respect to attempted private resolution of the complaint, WRPX, the translator licensee, is clearly aware of the complaints, as there have been two complete rounds of pleadings (complaint, supplement, response, reply) over a period of more than two years, and WRPX received an Order from the Commission directing it to shut down the translator. The attached Declaration of Patrick Wahl states that he contacted WRPX's technical consultant prior to the filing of Stewards' first interference complaint but was unable to resolve the interference problem

privately. Finally, the filing of an application to modify the translator's antenna pattern, BPFT-20180627AAB, is evidence of WRPX's attempt, albeit unsuccessful, to resolve the interference problem.

6. In light of the foregoing, Stewards submits that its complaint meets all requirements of the *Translator Interference Order*, and the directionalization of the translator's antenna has not resolved all listener complaints.<sup>6</sup> Accordingly, WRPX must be directed again to cease operation, to change translator channel (the preferred solution from Stewards' point of view), to reduce power overall, or at a minimum to reduce further the reach of the translator's signal in the direction of WWIB.

WWIB has been receiving interference from W279DD on the western side of their protected contour. The FCC has stated in R&O 18-119 that primary stations should be free of translator interference inside of their 45 dB $\mu$  contour.

#### Exhibit 2

**Figure 1** is an aerial map showing the WWIB 45 dB $\mu$  on the western side of their coverage area. **Figure 2** is an aerial map showing the WWIB Desired 45 dB $\mu$ -49.5 dB $\mu$  in .5 increments with the W279DD Undisired 25 dB $\mu$ -29.5 dB $\mu$  in .5 increments. Starting at the limit of 45 dB $\mu$  the opposing 25 dB $\mu$  was calculated using the Commission's standard contour prediction methodology. This represents -20 dB $\mu$  U/D Ratio for co-channel interference. Working inward to the point that co-channel interference no longer exist (49.5/29.5).

**Figure 3** shows the area at which the U/D Ratio exceeds -20 dB $\mu$  for co-channel interference. **Figure 4** shows the area of interference in relation to WWIB's 45 dB $\mu$  contour.

Figure 5 & 6 have pinpointed complaints received from listeners describing interference in the area.

#### Exhibit 2 Figure 1 Aerial Photo of the WWIB 45 dBµ Contour (50/50)







Exhibit 2 Figure 2 Aerial Photo of the WWIB Desired Contours (50/50) vs W279DD Undesired Contours (50/10)




#### Exhibit 2 Figure 3 Aerial Photo of the WWIB Contours vs W279DD Contours and U/D Interference Area




