



**ARTICLES OF AMENDMENT
TO THE RESTATED ARTICLES OF INCORPORATION OF
COMMONWEALTH PUBLIC BROADCASTING CORPORATION**

The undersigned, on behalf of the Corporation set forth below, pursuant to Section 13.1-888 of the *Code of Virginia*, states as follows:

1. The current name of the Corporation is **COMMONWEALTH PUBLIC BROADCASTING CORPORATION**.
2. The amendment adopted is to delete Paragraph 1 of the Restated Articles of Incorporation and to insert the following in its place:
 1. The name of the Corporation is **VPM MEDIA CORPORATION**.
3. The foregoing amendment was adopted on August 7, 2019, at a meeting of the Board of Directors at which a quorum was present. More than two-thirds of the Directors in office voted in favor of the amendment.
4. The amendment was adopted by the Board of Directors without member action. Member action was not required because the Corporation has no members.
