SUPPLEMENT TO OPPOSITION TO ORDER TO SHOW CAUSE

On November 12, 2019, Prescott Valley Broadcasting Co. Inc. ("PVBC") and ITM, LLC ("ITM") jointly filed an Opposition ("Opposition") to an October 10, 2019 Order to Show Cause ("Order"). On November 14, 2019, Entravision Holdings, LLC filed a Reply thereto, alleging, among other things, that the Opposition was defective because it was not accompanied by an affidavit from an individual.

The Order states that the procedures governing the Order to Show Cause process are set forth in Section 1.87 of the Commission's rules. Section 1.87(b) of the Commission's rules provides that any objection to an Order to Show Cause is "subject to the requirements of section 309 of the Communications Act of 1934, as amended" ("Act"). Section 309(b) of the Act provides, in pertinent part, that a party opposing an Order to Show Cause must include an affidavit from an individual if the opposition includes "allegations of fact, except for those of which official notice may be taken."

PVBC and ITM submit that the Opposition did not include any material allegations of fact, except for those of which official notice may be taken. Accordingly, PVBC and ITM believe that it was not necessary for the Opposition to include an affidavit from an individual. Nevertheless, by

this Supplement and out of an abundance of caution, PVBC and ITM jointly are submitting a Declaration executed by Sanford Cohen, the President of PVBC and the Managing Member of ITM. Mr. Cohen affirms, among other things, that all of the facts set forth in the Opposition are true and correct to the best of his knowledge. PVBC and ITM respectfully request, to the extent necessary, that the Commission incorporate Mr. Cohen's Declaration as part of the Opposition that PVBC and ITM filed on November 12, 2019.
