Dear Mr. Kitchen:

This is in reference to the request filed on November 18, 2019. Townsquare requests a further extension of the STA granted on November 12, 2013, as modified to continue operating with an ND antenna to allow time to complete repairs and file the required FCC Form 302 application (to update all operating parameters).¹ In support of the request, Townsquare states that additional time will be needed.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete, and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of STA IS HEREBY GRANTED, and Townsquare may continue to operate ND using tower #1 (ARSN 1224828) with a maximum of

0.625 kW day, and 0.25 kW night. Townsquare must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. Townsquare must submit the application or send an e-mail to my attention to certify the date the station resumed licensed operations per BML-20150806ABM with negligible changes.

This authority expires on **June 2, 2020**.
