Dear Mr. Vandewiele:

This is in reference to the request filed on December 17, 2019. SFL requests a further extension of the STA granted on November 17, 2016, to continue operating with parameters at variance due to the new South Bellevue Light Rail Station construction project located adjacent to the transmitter site.¹ In support of the request, SFL states that additional time will be needed pending completion of the project.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of the STA IS HEREBY GRANTED, and SFL may continue to operate with day and night parameters at variance and/or reduced power if

needed to maintain nighttime monitor points within licensed limits. SFL must reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. SFL must submit an e-mail to my attention to certify the date the station resumed licensed operations per BML-20130821ADN with negligible changes.

This authority expires on **July 26, 2020**.
