**Interference Complaint**

Dear Licensee:

This letter refers to an “Interference Complaint” (Complaint) filed on January 10, 2020, by Red Wolf Broadcasting Corporation (Red Wolf )<sup>1</sup> alleging that WYPH-LP, Manchester, Connecticut (WYPH-LP)<sup>2</sup> is causing interference to WDRC-FM in violation of section 73.807(e)(2)<sup>3</sup> of the Commission’s rules (Rules). In support, Red Wolf attaches six listener interference complaints.<sup>4</sup>

Section 73.807(e)(2)(ii) stipulates that “[a]n LPFM station that receives a waiver under paragraph (e)(1) of this section shall suspend operation immediately upon notification by the Commission that it is causing interference to the reception of an existing or modified full-service FM station.” In the underlying construct permit (Permit),<sup>5</sup> the Media Bureau (Bureau) granted New River’s request for a second adjacent channel waiver to WDRC-FM pursuant to section 73.807(e)(1)<sup>6</sup> of the Rules.

Accordingly, in light of the foregoing, IT IS ORDERED that, pursuant to sections 73.807(e)(2)(ii) and 0.283 of the Rules,<sup>7</sup> New River Community Church IS HEREBY ORDERED TO CEASE OPERATION OF LPFM STATION WYPH-LP, Manchester, Connecticut, IMMEDIATELY.<sup>8</sup>
