Dear Mr. Do:

This is in reference to the request filed on April 27, 2020. Intelli requests a further extension of the STA granted on September 17, 2014, to continue operating using the existing KZSJ(AM) tower to allow time to file the FCC Form 302 application to obtain a new license.¹ In support of the request, we noted that Intelli will require additional time to file the application to cover BP-20191015AAM.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:


- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA is GRANTED, and Intelli may continue to operate using the existing KZSJ tower as specified in BP-20191015AAM using a maximum of 1.5 kW day and 0.019 kW at night. Intelli must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

¹ KAZA(AM) is licensed for DA operation on 1290 kHz with 5 kW day and 0.088 kW night, and BP-20191015AAM authorizes use of the KZSJ tower using 1.5 kW day and 0.019 kW night.

This authority expires on **October 29, 2020**.
