Dear Mr. Price:

This refers to the above-captioned minor change application to correct coordinates and to add a 34 watts nighttime operation.

A preliminary study of the application reveals that the latitude is specified as 32° 22' 11.9" while it should be as 34° 22' 12". Also, you propose to add a 34Watt nighttime operation pursuant to the November 18, 1987 Order To Show Cause ("Order"). The Order authorized WGTJ to operate at nighttime with a power of 34 watts began within one year of the date of the Order and in compliance with the rules applicable to such operation. WGTJ did not notified the Commission of its intent to operate and did not begin to operate within the time period set by the Order. Therefore, WGTJ is no longer eligible for that power. The staff engineering studies show the proposal would enter the 25% RSS nighttime limitation of station WYRD, Greenville South Carolina, in violation of Section 73.182 of the Commission's rules. Accordingly, an amendment must be submitted to correct the latitude coordinates and to withdraws the nighttime operation.

Further action on the subject application will be withheld for thirty (30) days from the date of this letter, in order to provide an opportunity to file a curative electronic amendment. Failure to respond or file an amendment within this time period may result in the dismissal of the

application pursuant to Section 73.3568 of the Rules.
