Dear Mr. Spencer:

This is in reference to:

- (1) Your construction permit BPFT-20190618ABI,¹ which was granted February 20, 2020;
- (2) Your request for Special Temporary Authority, filed February 13, 2020; and
- (3) The February 20, 2020 informal objection, filed by Bicoastal Media Licenses IV, LLC against the request for STA.
- (4) The license application filed June 8, 2020, file number 0000115908, to cover construction permit BPFT-20200213ABI.

We start by considering the STA request. That request sought authority to operate at 10 watts of power, “due to excessively high reflective power” on the antenna and because the translator licensee was “waiting for [an] audio connection from KGTK”. The STA request sought the use of temporary facilities at the same site.

This STA request will be dismissed. The filing of the June 8, 2020 license application signals that K266BM has completed construction in accordance with its construction permit and is able to maintain sustained operations with the construction permit facilities. In other words, the STA is no longer needed. Concurrently, the informal objection filed by Bicoastal Media Licenses IV, LLC will also be dismissed.²

Accordingly, the request for Special Temporary Authority, file number BSTA-20200213ABI, IS DISMISSED, as is the informal objection filed by Bicoastal Media Licenses IV, LLC.

License application 0000115908 for K266BM will be processed in its turn. However, before we commence processing, Northwest Rock & Roll Preservation Society must provide written information (e-mail acceptable) to clarify:

- 1) What primary station K266BM is now relaying;
- 2) What effective radiated power K266BM is now operating with.
