



STATEMENT

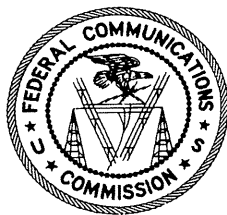
