Dear Mr. Liu:

This is in reference to the request filed on July 8, 2020. MRB requests a further extension of the STA granted on January 10, 2020, to continue operating with temporary parameters to allow time to install new guy wire anchor foundations for one tower used by KALI and KAHZ.¹ In support of the request, MRB stated that additional time will be needed to complete the foundations and relocate the guy wire cables.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of the STA IS HEREBY GRANTED, and MRB may continue to operate ND with a maximum of 1.25 kW day and night, or DA at night with parameters at

variance and reduced power to maintain nighttime monitor points within licensed limits. MRB must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. MRB must submit an e-mail to my attention to note the date the station resumed licensed operations per BL-19850228AH with negligible changes.

This authority expires on **January 23, 2021**.
