Dear Mr. Fernandez:

This is in reference to the request filed on July 10, 2020. INV requests a further extension of the STA granted on June 14, 2019, to continue operating ND with reduced power to allow time to complete fire related repairs and file the required FCC Form 302 application to update all operating parameters.¹ In support of the request, INV stated that it estimates the station should be able to complete all repairs by October.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:


- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA is **HEREBY GRANTED**, and INV may continue to operate ND with a maximum of 2.5 kW (daytime) and 0.0075 kW (nighttime). INV must reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §1.1310. INV must submit an e-mail to my attention to note the date the application was filed, or to note the date the station resumed licensed operations per BL-20040526ATG with negligible changes.

¹ WRJR(AM) is licensed for DA operation on 670 kHz with 20 kW (day) and 0.003 kW (night), using the same pattern.

This authority expires on **January 28, 2021.**
