Dear Mr. Davis:

This is in reference to the request filed on July 10, 2020. CLI requests an extension of the STA granted on January 15, 2020, to continue operating ND at night with reduced power to allow time to replace an underground transmission line for one tower.¹ In support of the request, CLI states that additional time is needed to complete all required repairs.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of STA IS HEREBY GRANTED, and CLI may continue to operate ND at night with a maximum of 12.5 kW, with g tower #1 of nighttime array with a reduced maximum power of 12.5 kW, with no change to the licensed daytime 50 kW ND operation. CLI must reduce the nighttime power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310. CLI must submit an e-mail to my attention to note the date the station resumed licensed operations

¹ WCKY(AM) is licensed for operation on 1530 kHz with 50 kW (ND day and DA night).

per BZ-20100525AFJ with negligible changes, or to note the date an FCC Form 302 application was filed to update all operating parameters.

This authority expires on **January 30, 2021**.
