Dear Mr. Angulo:

This is in reference to the request filed on July 20, 2020. ARC requests a further extension of the STA originally granted on October 29, 2004, to continue ND operation to allow time to complete construction of the new facility and file the required FCC Form 302 application.¹ In support of the request, ARC stated that it is in the final stages of construction of the new facility specified in BP-20170427AAE.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and ARC may

continue to operate ND using a maximum of 0.625 kW day and night. ARC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §1.1310. ARC must submit an e-mail to my attention to note the date the application was filed.

This authority expires on **February 10, 2021**.
