Dear Mr. Kaufman:

This is in reference to the request filed on July 29, 2020. BRE requests a further extension of the STA granted on July 23, 2012, as last modified on February 7, 2020, to continue operating from the KDNL(TV) transmitter site to allow time to file the required FCC Form 301 application.<sup>1</sup> In support of the request, we noted that the application for a permanent facility was not yet filed.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA is **HEREBY GRANTED**, and BRE may continue to operate daytime with the following facilities:

Geographic coordinates: 38° 38' 09" N, 90° 11' 45" W (NAD 1927)  
Frequency: 1010 kHz


<sup>11</sup> KXEN(AM) is licensed for DA operation on 1010 kHz with 50 kW (day) and 0.5 kW (night).

Operating power: 0.35 kW (day), 0.125 kW (night)  
Antenna: 74.2 m vertical wire supported on face of self-supporting tower located at KDNL(TV) studios

BRE must reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. BRE must submit an e-mail to my attention to note the date the application was filed.

This authority expires on **February 14, 2021**.
