This is in reference to the request filed on October 5, 2020. LBC requests a further extension of the STA granted on November 22, 1991, to continue operating with the facilities specified in BP-19900326AD on 1200 kHz due to the past unofficial change in the operating frequency of station HIBS, SP Macoris, Dominican Republic (from 1200 kHz to 670 kHz).¹ In support of the request, we note that BP-19900326AD remains on hold because the FCC's International Bureau has not received an official frequency change request for station HIBS from the government of the Dominican Republic.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to

expeditiously resolve the problem.

Accordingly the request for extension of the STA IS HEREBY GRANTED, and LBC may continue to operate using the parameters specified in BP-19900326AD. This authority is granted on the condition that LBC must resume licensed daytime only operation per BL-19860606AG if station HIBS is officially confirmed by the FCC's International Bureau staff to be operating on the frequency of 1200 kHz (which will result in the cancellation of this STA and dismissal of BP-19900326AD).

This authority expires on **April 12, 2021**.
