Dear Mr. Davis:

This is in reference to the request filed on October 2, 2020. IHM requests a further extension of the STA granted on February 8, 2018, to continue operating with parameters at variance to allow time to complete all remaining repairs.¹ In support of the request, IHM stated that additional time will be needed before it can resume licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of the STA IS HEREBY GRANTED, and IHM may continue to operate with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits. IHM must reduce power or cease operations if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure

guidelines. *See* 47 CFR § 1.1310. IHM must submit an e-mail to my attention to note the date the station resumed operations per BL-19850220AG with negligible changes, or the date an FCC Form 302 application was filed to update all operating parameters due to extensive repairs done over the past two years.

This authority expires on **April 20, 2021**.
