

### **Conversion to NCE Exhibit**

Pursuant to 47 CFR Section 73.1690(c)(9), Stu-Comm, Inc. ('Stu-Comm') is filing this application to seek approval for the operation of WHAN(AM), Ashland, VA as a noncommercial educational station. Following the recent grant of the assignment of license from Fifth Estate Broadcasting, LLC to Stu-Comm (*see* CDBS File No. BAL-20200807AAH) and its consummation, Stu-Comm has been operating the station as a noncommercial facility and seeks Commission designation of the station as a noncommercial facility. Stu-Comm is a non-profit entity that is already the licensee of a number of noncommercial educational stations including WNRN, Charlottesville, Virginia and WNRS-FM, Sweet Briar, Virginia, and thus its qualifications as a noncommercial licensee are a matter of record with the FCC.
