Dear Counsel:

This is in reference to the request filed January 10, 2008, on behalf of Genesis Communications I, Inc. ("GCI"). GCI requests extension of the special temporary authority ("STA") granted on October 15, 2007, to operate Station WHOO with parameters at variance and/or reduced power while maintaining monitor points within licensed limits.<sup>1</sup> In support of the request, GCI states that it recently replaced a phase monitor and sampling lines, which resulted in the need for measurements to confirm proper operation of the critical hours pattern for submission to the Commission. GCI states that the company which was to have performed the necessary measurements was delayed by the press of other business in commencing the measurements.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made progress toward restoration of licensed operation, but additional time is required for completing the work. Thus, extension of STA is warranted.

Accordingly, the request for STA IS HEREBY GRANTED. Station WHOO may operate with parameters at variance and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of

interference are received. GCI must notify the Commission when licensed operation is restored.<sup>2</sup> GCI must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **January 16, 2009**.
